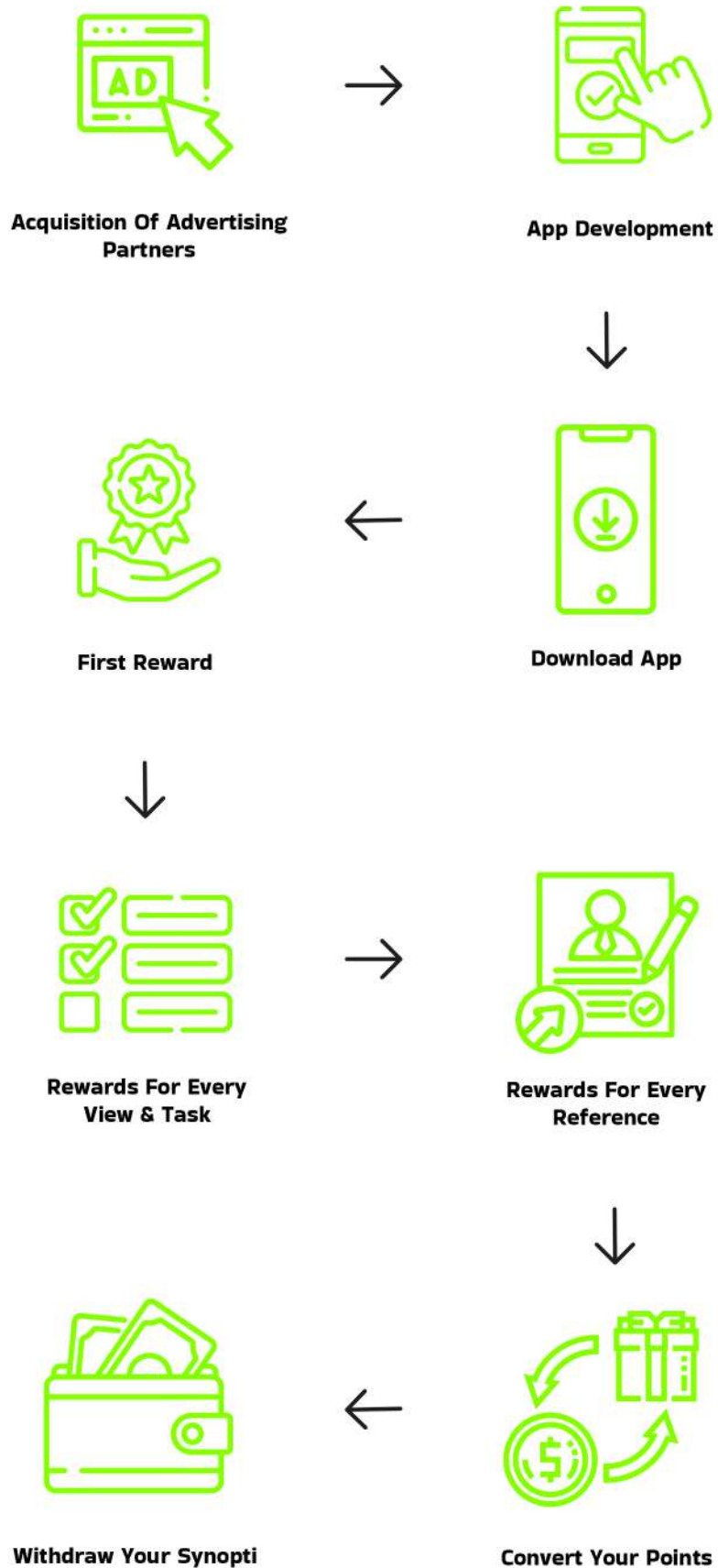

Introduction

Synopti Is A Technically-Secured Transferable Token.

Synopti Is Designed To Be Used Solely As An Interoperable Utility Token For A Representation Of Functions Specified In The Protocol/Contract.

Synopti – Token Use Cases

1. Exchange – Synopti Token Will Be Used As The Exchange Tool Among The Participants On The Synopti Platform. The Aim Of Introducing Synopti Is To Provide A Convenient And Secure Payment Of Participants Who Interact Within The Ecosystem Of The Synopti Platform Without Any Intermediaries Such As Centralised Third-Party Entity/Institution/Credit. Synopti Is Not, And Not Intended To Be, A Exchange Tool Accepted By The Public (Or A Section Of The Public) As Payment For Goods, Services Or For The Discharge Of A Debt.

Synopti Does Not Represent Any Shareholding, Participation, Right, Title, Or Interest In The Company, The Distributor, Their Respective Affiliates, Or Any Other Company, Enterprise Or Undertaking. Also Synopti Does Not Entitle Token Holders To Any Promise Of Fees, Dividends, Revenue, Profits Or Investment Returns, And Is Not Intended To Constitute Securities In Singapore Or Any Relevant Jurisdiction.
